

Illegal Drug Use Highest In A Decade

The rate of illegal drug use rose last year to the highest level in nearly a decade, fueled by a sharp increase in marijuana use and a surge in ecstasy and methamphetamine abuse, the government reported.

Gil Kerlikowske, the director of the Office of National Drug Control Policy, called the 9 percent increase in drug use disappointing but said he was not surprised given "eroding attitudes" about the perception of harm from illegal drugs and the growing number of states approving medicinal marijuana.

The annual report from the Substance Abuse and Mental Health Services Administration found marijuana use rose by 8 percent and remained the most commonly used drug.



About 21.8 million Americans, or 8.7 percent of the population age 12 and older, reported using illegal drugs in 2009. That's the highest level since the survey began in 2002. The previous high was just over 20 million in 2006. The survey is considered the most comprehensive annual snapshot of drug use in the United States.

Other results show a 37 percent increase in ecstasy use and a 60 percent jump in the number of methamphetamine users.

Drugged Driving Is On the Rise

According to a National Highway Transportation Safety Administration report, drugged driving is on the rise. The report, released in November, was the first ever study of drug involvement among deceased drivers in fatal crashes.


The rise of drug use in traffic fatalities has been fairly steady, the report showed: It was 13 percent in 2005, 15 percent in 2006, 16 percent in 2007, and 18 percent in 2008.

The types of drugs tested for included narcotics, hallucinogens, cannabinoids,

PCPs and inhalants, along with legally prescribed drugs and over-the-counter medicines.

Upon the release of the reports findings, NHTSA Administrator David Strickland said, "Today's report provides a warning signal that too many Americans are driving after having taken drugs, not realizing the potential for putting themselves and others on the highway at risk."

The table above (released by SAMHSA) shows percentages of Persons Aged 16 or Older Driving under the Influence of Illicit Drugs in the Past Year, by State: 2006 to 2009. The rates of drugged driving were among the highest in Rhode Island and Vermont and among the lowest in Iowa and New Jersey.

DEA Moves to Emergency Control Synthetic Marijuana




"NOV 24 -- WASHINGTON, D.C. – The United States Drug Enforcement Administration (DEA) is using its emergency scheduling authority to temporarily control five chemicals used to make "fake pot" products. Except as authorized by law, this action will make possessing and selling these chemicals or the products that contain them illegal in the U.S. for at least one year while the DEA and the United States Department of Health and Human Services

(DHHS) further study whether these chemicals and products should be permanently controlled

Over the past year, smokable herbal blends marketed as being "legal" have become increasingly popular. These products consist of plant material that has been coated with research chemicals that mimic THC, the active ingredient in marijuana, and are sold at a variety of retail outlets, in head shops and over the Internet. These chemicals, however, have not been approved by the FDA for human consumption and there is no oversight of the manufacturing process. Brands such as "Spice," "K2," "Blaze," and "Red X Dawn" are labeled as incense to mask their intended purpose."

Hopefully this measure by the DEA will lessen the popularity of these products. At this time, there are no FDA cleared assays to screen for synthetic marijuana products, or established cut off levels. The ban mentioned above includes five chemicals used to make synthetic marijuana, however there are over 400 more chemicals that can be substituted in, making an effective drug test for these products very difficult.



New FedEx Rate for 2011

13 Chrysler Workers Fired For Alcohol/Drug Use During Lunch

Thirteen plant workers at the Chrysler Jefferson North Assembly plant in Detroit have lost their jobs after a video

was aired on the Detroit Fox affiliate.

An exclusive investigation by MyFoxDetroit.com showed workers at the plant drinking beer and smoking joints while on a half-hour lunch break just two months after President Obama praised the plant in a speech.

The TV station's investigation -conducted over several weeks and based on tips from workers at the plant -- had outraged the auto giant's top executives, who called the behavior "totally unacceptable."

Vicodin - Americas Most Popular Drug

A narcotic painkiller tops Forbes' list of the most prescribed medicines. The drug is Vicodin, a 40-year old addictive medicine that combines the narcotic Hydrocodone with acetaminophen, the active ingredient in Tylenol.

It is particularly dangerous because when patients develop a tolerance for the narcotic they start taking too

This can lead to liver failure from overdoses of the acetaminophen component of the combo. Most of the 400 deaths due to acetaminophen poisoning each year result from misuse of Vicodin or similar drugs.

Employee Sold Drugs Out of City Truck

A former Niagara Falls city worker is headed to prison for selling drugs out of his city truck.

A judge sentenced Rodney Ingram to a five year term Monday in Niagara County Court. He worked for the city for 22 years, but was fired after police charged him with trying to sell crack cocaine to an undercover detective last year.

Police say they tracked Ingram's activities for months before luring him with the prospect of a drug deal. The investigators stated that Ingram came in a Niagara Falls Water Board truck and was apprehended with \$2,000 in cash and three rocks of crack cocaine.
