THE SCIENCE BEHIND IT ALL

Hair testing is based on the scientific principle that ingested drugs accumulate permanently in hair.

The ingested drugs are accumulated in proportion to their use and provide a permanent historical record of abuse. Through a patented process, Psychemedics extracts ingested drugs from a hair sample, and through the use of sophisticated screens and mass spectrometry identifies and quantitates the drug.


